Admissions & Document Verification

High application volumes and diverse credential formats slow enrolment decisions and increase rejection risk; VectorMind automates verification, equivalence checks and conditional offer workflows to accelerate admissions and protect quality.

How it works:

Ingest: Iris ingests online application forms, scanned transcripts, referee letters, passports and agent uploads via secure portal.

Extract & Normalise: Iris extracts applicant identifiers, module codes, grades, award authorities and document metadata; normalises grade scales and dates.

Verify & Cross-check: Neuroflow cross-references awarding-body registries, qualification databases and prior application records; Atlas links supporting documents and prior verifications to build an evidential graph for each applicant.

Reason & Recommend: Business GPT assesses equivalence (international qualifications), flags missing or suspicious items (possible fraud) and suggests offers (conditional/firm) with cited evidence.

Orchestrate Actions: Neuroflow issues conditional offers, schedules required checks (DBS, visa evidence), opens exception cases for verification failures and routes them to admissions/officer with prefilled dossiers and SLA deadlines.

Search & Audit: Synaptic Search surfaces historical equivalence decisions and precedents to support consistent decisioning.

- **Faster admissions decisions** and higher conversion through quicker verification and conditional offer issuance.
- **Reduced fraud & mis-acceptances** via automated checks and provenance-linked evidence.

How it works:

Iris ingests case referrals, medical notes, accommodation requests, counselling records and communications and Atlas links these to the student's academic and conduct history. Neuroflow creates triage workflows, attaches pre-filled evidence dossiers and enforces SLA-bound actions while Business GPT summarises case risks and recommended interventions for student support teams.


Student Finance, Fee Recon & Debt Recovery
