Precedent & Case Law Discovery

Large firms and legal teams maintain massive, fragmented libraries (opinion memos, precedents, court judgments, client files). Keyword search returns noise; finding the best precedents and related matters is slow and inconsistent.

Solution (products)

Atlas (enterprise discovery, graphing, multi-search planner) + Knowledge Nodes (domain-tuned embeddings and summarisation).


How it works:

User submits a natural-language query (web, chat or matter UI): e.g., “Find precedents on fiduciary duty in procurement contracts, with supporting excerpts.”

Atlas’s planner selects search strategies (semantic embeddings, meta data filters, keyword matches, external sources if authorised) and runs them in parallel across indexed content.

Results are aggregated into a relationship graph linking matters, documents, authors and citations; Knowledge Nodes generate concise, source-linked summaries and suggested excerpts or clauses.

The user receives a ranked set of precedents with contextual snippets, provenance links, and suggested next steps (cite block, redline starter, or related matters). auto-approves low-risk claims or routes to an adjuster with a prefilled dossier.



Gains

- Faster, **higher-quality research** than keyword search.
- Consistent **use of firm precedents** and reduced duplicative research.
- Contextual discovery: **surfacing related matters**, authors and internal expertise.
- Source-linked answers that **preserve provenance for citation** and defensibility.
- **Reduced external research** spend and junior lawyer hours.
- Time-to-find high-value precedent: reduced by **60-80%** (typical).
- Document repositories (SharePoint, iManage, NetDocuments), court databases, and local research subscription **integrations**.
- Easy-to-access **AI built into Microsoft 365 Suite**.
- Access controls honour matter-level **permissions and privilege**.
- Citation and provenance **tracking maintained for every retrieved snippet**.
- Full auditing of search queries and results for **compliance and conflict checks**.





Matter Intake & Triage



What it does:

Incoming matters arrive via email, web forms, phone and uploads in inconsistent formats (PDFs, scans, Word, images). Manual intake is slow, error-prone and causes missed deadlines, misrouted matters and poor client experience. With Iris (AI ingestion & extraction) & Knowledge Nodes (domain knowledge, conversational intake) & Neuroflow Agentic Workflows (orchestration, routing, human-in-loop) these issues are mitigated.



How it works:

Uploaded files are auto-ingested by Iris: OCR, table and clause extraction, parties, dates, deadlines, key obligations and exhibits are converted into structured JSON. Neuroflow validates extracted fields, applies triage rules, and either auto-assigns to a team or routes for human review.

More Legal Use Cases



Contract Review & Clause Extraction

Auto-extract clauses, obligations, dates and obligations from contracts and generate first-pass redlines, annotations and negotiation talking points for faster review cycles & load handing.



Due Diligence & M&A Document Analysis

Bulk ingest data rooms to extract entities, anomalies and cross-document linkages; surface risk items and produce summary reports for buyers/sellers. Shorter DD timelines with higher coverage.



Litigation Support & e-Discovery

Process terabytes of documents, extract metadata & evidentiary snippets, then map relationships between parties, communications and timelines for case teams. Faster evidence curation, clearer timelines, reduced discovery costs.



Legal Research Assistant & Drafting Support

Generate research summaries, cite sources, propose draft pleadings, letters and precedents tuned to firm style and jurisdictional rules. Higher junior lawyer productivity, consistent first drafts, faster turnaround.



Compliance Monitoring & Regulatory Reporting

Continuously scan policy libraries, filings and correspondence to surface compliance gaps and prepare regulator-ready reports with evidence links. Proactive compliance, reduced regulatory risk, auditable trails.



Knowledge Management & Internal Expertise

Finder Natural-language search across internal memos, opinions and matter notes to find subject-matter experts, prior work and relevant guidance. Less duplicated work, faster onboarding, better utilisation of firm expertise.




Invoice & Trust Accounting Reconciliation
