Contracts, Leases & Royalty Management

Complex contracts and dispersed amendments create hidden obligations and revenue leakage; VectorMind centralises clause extraction, links precedent and automates royalty workflows so you never miss a payment trigger.

How it works:

- **Ingest:** Iris ingests contract PDFs, scanned amendments, exhibits & emails via secure connectors or portal uploads.
- **Extract:** Iris applies schema-driven extraction to pull clause text, effective dates, payment terms, royalty formulas, geolocations & contract parties.
- **Link & Contextualise:** Atlas links the primary agreement to amendments, SORs, exhibits & historical precedents; creates an evidentiary graph of obligations & dependencies.
- **Normalise & Validate:** Neuroflow cross-references extracted fields with ERP billing records, production allocations and land/lease registries to validate payee IDs and amounts.
- **Reason & Recommend:** Business GPT generates an explainable obligations summary (key dates, payment triggers, conflict flags) and proposes remediation or redline language where clauses conflict.
- **Orchestrate Actions:** Neuroflow auto-generates templated notices, schedules approvals (RBAC via Entra ID), triggers payment holds or releases, & routes exceptions to legal/finance with a prefilled dossier including extraction confidence and provenance links.
- **Search & Audit:** Synaptic Search surfaces similar clause precedents; Atlas & Knowledge Nodes provide auditors with a time-stamped evidence pack for each royalty decision.

Trading, Risk & Position Management



What it does:

Trading combines rapid market moves with complex physical logistics; VectorMind reconciles paper & physical records, surfaces exposures & provides explainable recommendations so traders and risk managers act with confidence.

Iris ingests trade blotters, confirmations and market feeds, normalises attributes and maps trades to internal positions. Neuroflow reconciles paper trades with physical deliveries and custody receipts, assembles evidence via Atlas, and opens exception workflows; Business GPT then generates explainable P&L/exposure summaries and hedge recommendations, with Synaptic Search enabling rapid forensic queries.

More Oil & Gas Use Cases



Production Reporting & Allocation

Manual reconciliation of SCADA, meter tickets & custody transfers creates allocation errors & delayed month-end reporting. Iris normalises telemetry & meter tickets.



Supply Chain, Logistics & Terminal Operations

Bills of lading, manifests & terminal receipts are processed manually across siloed systems, increasing demurrage risk and slowing claims. Iris extracts shipment & weighbridge data, Neuroflow matches shipments to POs/receipts & triggers demurrage claims



Regulatory Reporting & Compliance

Diverse regulator formats & audit evidence demands make filings time-consuming & risky. Iris ingests filings & permits, while Atlas assembles source-linked evidence graphs.



HSE & Incident Investigation

Incident records, photos & sensor spikes are scattered, slowing root-cause analysis & corrective action. Iris ingests incident forms, logs & media, Atlas correlates incidents with work orders and permits, Business GPT generates initial RCA.



Asset Integrity & Maintenance Optimisation

Inspection records & OEM manuals are fragmented, leading to reactive maintenance and spare-parts uncertainty. Iris extracts inspection & NDT reports, Atlas correlates asset histories & OEM guidance, Business GPT prioritises maintenance & spare lists with evidence, while Neuroflow schedules work orders and procurement.



Joint Venture Accounting & Revenue

Complex JV participation factors & partner invoicing cause slow, error-prone reconciliations & disputes. Iris captures invoices & JV statements, Atlas maps agreements and participation factors, Neuroflow executes reconciliation rules.
